TERMS AND CONDITIONS – SKI RENTAL – Rules and rental conditions

- The customers (here also referred to as rentee) claims full responsibility for the rental object. The rented item ought to be used by the customer only. Subletting and sharing the rental object with third parties (even free of charge) is prohibited.
- The renting item is not insured against theft. In case the item breaks down during proper usage, the rentee will not be charged.
- In case of loss or theft of the rental object, the rentee will be charged or attributed the amount of the market value.
- In case of theft or loss of the rental object, the customer must report to the local authorities.
- Every rentee is liable for properly return of the rental object up to the amount of the market value of the rental object. In case of improper usage, resulting in damage of the rented item (without liability insurance) the rentee will be charged for repair costs according to the current pricing list for ski services.
- The exchange of the rental object is possible for an equivalent item anytime during the contract duration. You may also exchange the current item for an item of higher category for an additional charge. However, please note that if you change your current for a cheaper item, the initial costs are not refundable.
- The rental object must be paid by the return day. The latest possible return date is 10.00 am the following day (of the last rental day).
- In case the rental object will not be returned by on the agreed day, the rental company will automatically press charges for theft against the customer on the 7th day of delay.
- If you return the rental object in advance, we do not grant a refund.
- We only grant refunds in case of sickness and/or an accident if you submit a medical certificate.
- For the assembly, the repair and the setup of the ski binding we demand an ordinary rental contract. By signing this contract, you agree to a professional ski binding setup according to the manufacturer's regulations and accept the rental terms and conditions.
- For closing the contract we require an ID and a credit card. The rental rental company is entitled to ask for ID (passport, ID card, diving license) or/and a deposit as liability. The provided liability does not count as a potential purchase price of the sports equipment.
