

## REGULATION DOG FRIENDLY HOTELES GAMMA



Gamma Guaymas Armida Hotel is dog friendly (see Pet Friendly hotels). Therefore it is essential that you know the rules for dogs entering our building.

- 1 The owner or guardian of the dog is directly responsible for the mischievous, careless or presented behavior caused by the pet in a given situation.
- 2 The owner(s) or the person in charge of the dog will be responsible for any visitor or pet whose physical or emotional integrity is affected. Pets are allowed, as long as they are domestic animals (dogs). Under no circumstances will animals such as reptiles, arachnids, birds, among other species prohibited by law, be allowed to enter.
- 3 According to Law 746 of 2002, large, medium or highly dangerous breeds: American Staffordshire Terrier, Bullmastiff, Doberman, Dogo Argentino, Dogo de Burdeos, Fila Brasilero, Mastrín Napolitano, Pit Bull Terrier, Amercian Pit Bull Terrier, De Presa Canario, Rottweiler, Staffordshire Terrier, Tosa Japonés, must wear a muzzle at all times. Likewise, the owners, possessors or keepers of these dogs, must carry the document that accredits their registration before the competent Municipal Administration.
- 4 Gamma Guaymas Armida Hotel reserves the right to admit any of these pets, in case it is considered convenient for the safety of its visitors.
- <sup>5</sup> When entering the pets, it is understood that the owners or person in charge of them declare that their pets do not belong to the breeds covered in Article 108 of Law 746 of 2022 (potentially dangerous dogs) and in case of belonging to one of these breeds, have taken the necessary measures, such as the placement of muzzle and leash. Article 57 of Decree 2257 of 1986.
- 6 Dogs that do not comply with all the regulations (vaccination card, walking collar) are not allowed to enter.
- 7 Please note that for the entry of the dog, they must comply with the regulations of vaccination, health and safety. In case of an eventuality, you must have your vaccination card at hand.
- 8 Your dog must always be with a responsible adult while in the hotel facilities. The pet may not be left alone in the room, except for 30 minutes at breakfast time.
- 9 Children must not be alone with the dog.
- 10 It is forbidden to use the crockery and glassware intended for our guests, to feed your dog. The Owner must carry the necessary feeding bowls for this purpose.
- **11** It is forbidden to bathe the dogs in the showers of the room (as well as the use of towels).







- 12 Dogs are not allowed in the room during the cleaning service. Please notify the hotel front desk so that they can tidy up and clean the room.
- 13 During your visit to the hotel, your dog must wear a collar and leash at all time.
- 14 Your dog must not circulate in areas of the hotel that are not permitted: restaurant, wet areas (swimming pool) and lounges (except in cases where the dog is a guide). If the dog is a guide, can accompany his master throughout his tour in the hotel.
- To avoid accidents, never let your dog loose while inside the hotel facilities.
- To keep a clean and pleasant space, avoid letting your dog relieve itself in the public areas of the hotel.
- Pick up and clean up solid and liquid waste in case of doing so.
- The guest is obligated and responsible for cleaning up the dog's waste.
- In the assigned area, the guest is obliged to carry a plastic bag to pick up the dog's waste.
- The hygiene of your dog, as well as the area where he stays, is the guest's responsibility. Always have your cleaning kit at hand.
- The hotel provides you with a kit for the collection of excrements in case you need it (not included). Please ask at the hotel reception desk.
- 15 If your dog leaves liquid or solid waste on carpets, beds, mattresses, sofas, decorative chairs or any other element of the hotel, the cleaning of the same will be the responsibility of the owner. If it is not possible to clean it, the owner must pay for the product.
- 16 This regulation applies from the first moment the dog enters the hotel.
- 17 All damages caused by the dog in the hotel installations must be assumed by the owner, for this reason, you must have a credit card guarantee and if the damage exceeds the value of the guarantee, you must pay the excess with another means of payment.

Please avoid bringing dogs that usually bark too much or are aggressive with people or other pets. The complaint of any other guest will be taken with the utmost seriousness and it will be the decision of the administration to terminate the housing contract.

If it is a guide dog, please notify us. In this case, some points of these regulations may not apply.
