2.1. Period of retention of your data

We will keep your personal data from the time you give us your consent until you revoke it or request the limitation of processing. In such cases, we will keep your data in a blocked form for the legally required periods.

3. LEGITIMACY AND DATA COLLECTED

The legitimacy for the processing of your data is the express consent given by a positive and affirmative act (fill out the appropriate form and check the box of acceptance of this policy) at the time of providing your personal data.

3.1. Consent to process your data
