The parties agree that all decisions of the Arbitrator shall be conclusive and binding on all parties and that each side in any dispute will bear half the costs involved in any arbitration. This arbitration agreement covers all claims as set forth herein between the undersigned and The Buccaneer, Inc. and/or its agents, directors, officers and employees and will continue from the time of the acknowledgment of this agreement by the undersigned until it is otherwise terminated in writing by the agreement of the parties. In the event a court or arbitrator declares that the arbitration clause is not enforceable or does not cover the claim in question, then the parties agree that the matter will proceed in court as a non-jury trial AS EACH PARTY EXPRESSLY WAIVES ITS RIGHT TO A JURY TRIAL IN ANY SUCH PROCEEDING.

III. Any guest of The Buccaneer shall be liable to compensate this hotel for any damage (including the replacement cost thereof) created by him/her to The Buccaneer property.

IV. The Buccaneer cannot be held liable for any losses or personal effects and limit their liability according to the Hotel Properties Act of 1975
