The reservation team will then contact you to confirm your reservation.

- UniLodge City Gardens is purpose-built student accommodation, you are required to provide proof of student status (such as Confirmation of Enrolment, Student ID) and valid Visa (if applicable) as well as legal photo ID (passport or drivers licence).
- The Short Stay must be a minimum of 2 weeks (14 days) and must not exceed 7 weeks (49 days). All bookings must end on or prior to 23<sup>rd</sup> January 2023.
- The Short Stay must be paid in full prior to the commencement of the stay. A deposit of one (1) week stay is required to secure your booking, and invoice for the stay will be sent to you from the reservation team.
- A Security Deposit of \$500.00 is included in the Short Stay and is refundable at the end of the stay unless incidentals occur. If incidentals occur in the apartment, the Security Deposit may not be fully refundable.
- A compulsory cleaning fee of \$132.00 is included in the total cost of the Short Stay.
- All guests at the property must read and abide by the UniLodge House Rules detailed in the <u>Resident Handbook</u> and sign and return the final page as acknowledgement prior to commencement of stay.
- Once the Short Stay has commenced, the dates of stay cannot be reduced. If an extension of stay is required, consideration of extension will need to be reviewed in writing to reservations.citygardens@unilodge.com.au 48 hours prior to the stay end. The stay must not exceed 7 weeks (49 days).
