- 2. We will collect your personal information or personal data directly from you (including any unsolicited information or data you may provide in the body of your enquiry). In certain circumstances, We may be required to collect personal information or personal data from third parties, depending on the nature of your enquiry.
- We collect your personal information or personal data for the primary purpose of processing your application for enrolment at one of our residences and verifying your details, and enrolment at an eligible University. For UniLodge Park Avenue property only, this includes conducting background screening (including sanctions checks, politically exposed persons screening, and adverse media reviews) both initially and periodically during your tenancy as required by our property owner. You agree to your personal information or personal data being collected and used for, and in connection with, these purposes and any other purpose described in our Privacy Policy.
- 4. If we do not collect this personal information or personal data in connection with the purposes in paragraph 3, then we may be unable to process your application, or supply you with information in relation to your application. For UniLodge Park Avenue property, this includes where required background screening cannot be completed or where screening results do not meet our property owner's requirements.
- 5. In some instances, we employ computer programs to process your application and verify documents containing your personal information or personal data. By submitting your application, you consent to the processing of your documents by our computer programs. Please contact us if you would prefer not to have your documents processed by computer programs, or to request information about the computer processing of your data, to object to such processing, or seek human intervention in any automated decision-making processes.
- 6.
